As a sponsor accredited by the Accreditation Council for Continuing Medical Education (ACCME), The University of Arizona College of Medicine at the Arizona Health Sciences Center must ensure balance, independence, objectivity and scientific rigor in all its sponsored educational activities. All presenters must disclose to the activity audience any significant financial interest or other relationships that may affect the presentation.

The intent of this disclosure is not to prevent faculty with a significant financial or other relationship from presenting, but to provide listeners the information to form their own judgments. It is for the audience to decide if the speaker's interest or relationships may affect the presentation in regard to exposition or conclusion.

Classification:

- **Commercial Interest**-The ACCME defines a "commercial interest" as any proprietary entity producing health care goods or services, with the exemption of non-profit or government organizations and non-health care related companies.
- **Financial Relationships**-Financial relationships are those relationships in which benefit is received by receiving a salary, royalty, intellectual property rights, consulting fee, honoraria, ownership interest (e.g., stocks, stock options or other ownership interest, excluding diversified mutual funds), or other financial benefit. Financial benefits are usually associated with roles such as employment, management position, independent contractor (including contract research), consulting, speaking and teaching, membership on advisory committees or review panels, board membership, and other activities from which remuneration is received, or expected. ACCME considers relationships of the person involved in the CME activity to include financial relationships of a spouse or partner.
- **Relevant Financial Relationships**-ACCME focuses on financial relationships with commercial interests in the 12-month period preceding the time that the individual is being asked to assume a role controlling content of the CME activity. ACCME has not set a minimum dollar amount for relationships to be significant. Inherent in any amount is the incentive to maintain or increase the value of the relationship. The ACCME defines "relevant" financial relationships as any amount occurring within the past 12 months that create a conflict of interest.
- **Conflict of Interest**-Circumstances create a conflict of interest when an individual has an opportunity to affect CME content about products or services of a commercial interest with which he/she has a financial relationship.
